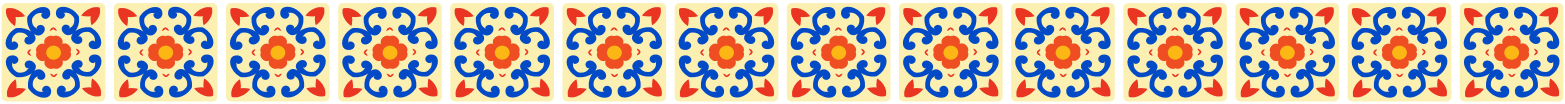

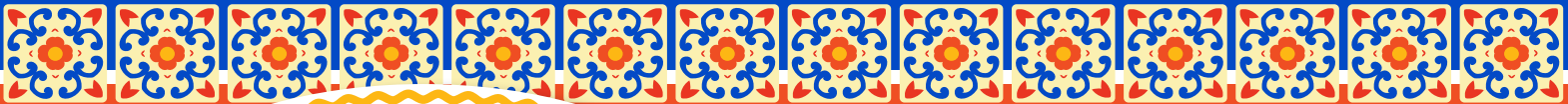

HONORING

Judge Carlos Villalon



The **Honorable Carlos Villalon, Jr.** was appointed as Associate Judge for the Child Protection Court of the Rio Grande Valley West on June 4, 2012 and presides over child welfare cases in both Hidalgo and Starr Counties. He has served as Commissioner of the Texas Children's Commission and currently serves on the Commission's Statewide Collaborative on Trauma-Informed Care ("SCTIC") Implementation Task Force. His court is also an active participant in the National Council of Juvenile and Family Court Judges' Implementation Sites Model Courts Project. Judge Villalon earned his bachelor's degree in Political Science from the University of Texas-Pan American in 1991; and after teaching middle school students for two-years in La Joya, Texas, he pursued his post-graduate education at St. Mary's University-School of Law where he earned his Doctor of Jurisprudence degree in 1997. His career as an attorney has spanned both the private and public sectors with an emphasis in Child Advocacy, Indigent Representation, Family Law, and Bankruptcy Law. His previous public service includes practice as an Assistant Criminal District Attorney, Assistant Attorney General, and Regional Attorney with the Texas Department of Family and Protective Services.
